Entry to the swim sessions

The council requires that you are the guest of a member or a member of a naturist organisation or club before you arrive. Members of other naturist clubs and organisations are welcome to attend, but we will need to see evidence of membership, name and address every time.

Joining

You can join by post, email, phone or in person at Barton Mills Post Office.

We do need to see evidence of name and address. A driving license is preferred but any official document with name and address will do, for example a household bill. Please do not send documents by post. We will check them when you first attend and the membership cards will be ready the next time.

The membership fee for 2010 is £6, and £5 for each additional adult at the same address, children free. Cheques payable to MNSC please. Join in September and October for half price. If you join in November or December it runs to the end of the following year. Once you have an MNSC membership card that is all you need for admission but unfortunately you do also have to pay the pool admission. If your card is lost or stolen, please let us know immediately.

Members may bring guests on payment of the visitors fee (adults £1, children free) and production of identification to establish name and address. Pool charges also apply.

In case of difficulty over identification please give us a phone call.

The undertaking that you sign

The MNSC list of the unwelcome is empty, and based on the experience of other swims it is most unlikely that this will change. We can not keep a list without this statement. Organisers of other naturist events, CCBN and law enforcement agencies can inquire if someone is on the list. If you have been barred from another naturist club or organisation, you are not automatically excluded from joining (it might have been something trivial 50 years ago) but it must be discussed with us and we may need to contact the other club.

It should be obvious why the rest of the paragraph is there.

Confidentiality

The membership list is completely confidential although it may be divulged for law enforcement purposes. We will also provide references to other clubs if they quote both name and membership number. Otherwise we neither confirm nor deny anything!

If someone is a nuisance (or worse)

At any swim, naturist or textile, very occasionally someone is a nuisance. It is very rare but it is best to be prepared.

If someone is a nuisance, or makes you feel uncomfortable, or worse, please let us know, even if you think it could have been an accident or too trivial to be worth mentioning. It may be part of a pattern of unacceptable behaviour and if nothing is done about it it may get worse. We will discuss with you what action to take, including keeping your name out of it if that is your wish.

Conclusion

These precautions are a bit "over the top" but council's are rather nervous about naturists using their pools.
